

The relative strengths and weaknesses of Wiwog Wittenberger Wohnungsbaugesellschaft mbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Wiwog Wittenberger Wohnungsbaugesellschaft mbH compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 117% points. The greatest weakness of Wiwog Wittenberger Wohnungsbaugesellschaft mbH is the variable Is Netincome Regular, reducing the Economic Capital Ratio by 5.467% points.

The company's Economic Capital Ratio, given in the ranking table, is 117%, being 245% points below the market average of 361%.
