



The relative strengths and weaknesses of Stralsunder Wohnungsbaugesellschaft mbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Stralsunder Wohnungsbaugesellschaft mbH compared to the market average is the variable Bs Eqliab Liab Trade Remainder, increasing the Economic Capital Ratio by 2.529% points. The greatest weakness of Stralsunder Wohnungsbaugesellschaft mbH is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 40.134% points.

The company's Economic Capital Ratio, given in the ranking table, is 2.529%, being 2.168% points above the market average of 361%.
