



The relative strengths and weaknesses of Peter Ahrens Bauunternehmen GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Peter Ahrens Bauunternehmen GmbH compared to the market average is the variable Gross Revenue For The Period Tc, increasing the Economic Capital Ratio by 111% points. The greatest weakness of Peter Ahrens Bauunternehmen GmbH is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 1.050% points.

The company's Economic Capital Ratio, given in the ranking table, is 111%, being 8,2% points above the market average of 103%.
