The greatest strength of Brüninghoff GmbH Co KG compared to the market average is the variable Gross Profit Tc, increasing the Economic Capital Ratio by 83% points. The greatest weakness of Brüninghoff GmbH Co KG is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 780% points.

The company's Economic Capital Ratio, given in the ranking table, is 83%, being 20% points below the market average of 103%.
