



The relative strengths and weaknesses of Wohnbauten GmbH Schwedt Oder are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Wohnbauten GmbH Schwedt Oder compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 183% points. The greatest weakness of Wohnbauten GmbH Schwedt Oder is the variable Gross Profit Tc, reducing the Economic Capital Ratio by 286% points.

The company's Economic Capital Ratio, given in the ranking table, is 191%, being 88% points above the market average of 103%.
