



The relative strengths and weaknesses of Hubert Schmid Bauunternehmen GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Hubert Schmid Bauunternehmen GmbH compared to the market average is the variable Is Netincome Regular, increasing the Economic Capital Ratio by 124% points. The greatest weakness of Hubert Schmid Bauunternehmen GmbH is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 191% points.

The company's Economic Capital Ratio, given in the ranking table, is 149%, being 46% points above the market average of 103%.
