



The relative strengths and weaknesses of Fuchs Bau Gesellschaft mbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Fuchs Bau Gesellschaft mbH compared to the market average is the variable Is Netincome Regular Operatingcogs Grossoprofit Remainder, increasing the Economic Capital Ratio by 66% points. The greatest weakness of Fuchs Bau Gesellschaft mbH is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 11.123% points.

The company's Economic Capital Ratio, given in the ranking table, is 66%, being 37% points below the market average of 103%.
