



The relative strengths and weaknesses of Josef Pfaffinger Bauunternehmung GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Josef Pfaffinger Bauunternehmung GmbH compared to the market average is the variable Operating Result Tc, increasing the Economic Capital Ratio by 147% points. The greatest weakness of Josef Pfaffinger Bauunternehmung GmbH is the variable Is Netincome Regular Remainder, reducing the Economic Capital Ratio by 976% points.

The company's Economic Capital Ratio, given in the ranking table, is 147%, being 43% points above the market average of 104%.
