The greatest strength of Bien Zenker GmbH compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Remainder, increasing the Economic Capital Ratio by 63% points. The greatest weakness of Bien Zenker GmbH is the variable Is Netincome Regular Operatingtc Remainder, reducing the Economic Capital Ratio by 781% points.

The company's Economic Capital Ratio, given in the ranking table, is 63%, being 41% points below the market average of 104%.
