

The relative strengths and weaknesses of Städtische Wohnungsgesellschaft Altenburg mbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Städtische Wohnungsgesellschaft Altenburg mbH compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 94% points. The greatest weakness of Städtische Wohnungsgesellschaft Altenburg mbH is the variable Gross Profit Tc, reducing the Economic Capital Ratio by 265% points.

The company's Economic Capital Ratio, given in the ranking table, is 95%, being 9,3% points below the market average of 104%.
