



The relative strengths and weaknesses of HBG Bau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of HBG Bau GmbH compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 122% points. The greatest weakness of HBG Bau GmbH is the variable Operating Result Tc, reducing the Economic Capital Ratio by 319% points.

The company's Economic Capital Ratio, given in the ranking table, is 122%, being 8,6% points below the market average of 130%.
