



The relative strengths and weaknesses of Helma Eigenheimbau Aktiengesellschaft are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Helma Eigenheimbau Aktiengesellschaft compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Remainder, increasing the Economic Capital Ratio by 165% points. The greatest weakness of Helma Eigenheimbau Aktiengesellschaft is the variable Is Netincome Regular Operatingtc Remainder, reducing the Economic Capital Ratio by 465% points.

The company's Economic Capital Ratio, given in the ranking table, is 169%, being 39% points above the market average of 130%.
