



The relative strengths and weaknesses of Städtische Wohnungsbau GmbH Göttingen are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Städtische Wohnungsbau GmbH Göttingen compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 67% points. The greatest weakness of Städtische Wohnungsbau GmbH Göttingen is the variable Gross Profit Tc, reducing the Economic Capital Ratio by 213% points.

The company's Economic Capital Ratio, given in the ranking table, is 67%, being 34% points below the market average of 102%.
