

The relative strengths and weaknesses of Bauwerke Bauträger GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Bauwerke Bauträger GmbH compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 38% points. The greatest weakness of Bauwerke Bauträger GmbH is the variable Gross Profit Tc, reducing the Economic Capital Ratio by 162% points.

The company's Economic Capital Ratio, given in the ranking table, is 38%, being 63% points below the market average of 102%.
