



The relative strengths and weaknesses of Porr Industriebau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Porr Industriebau GmbH compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Totaloutput Netsales Remainder, increasing the Economic Capital Ratio by 177% points. The greatest weakness of Porr Industriebau GmbH is the variable Is Netincome Regular Operatingtc Grosstradingprofit Totaloutput Inventorychange Remainder, reducing the Economic Capital Ratio by 539% points.

The company's Economic Capital Ratio, given in the ranking table, is 177%, being 77% points above the market average of 100%.
