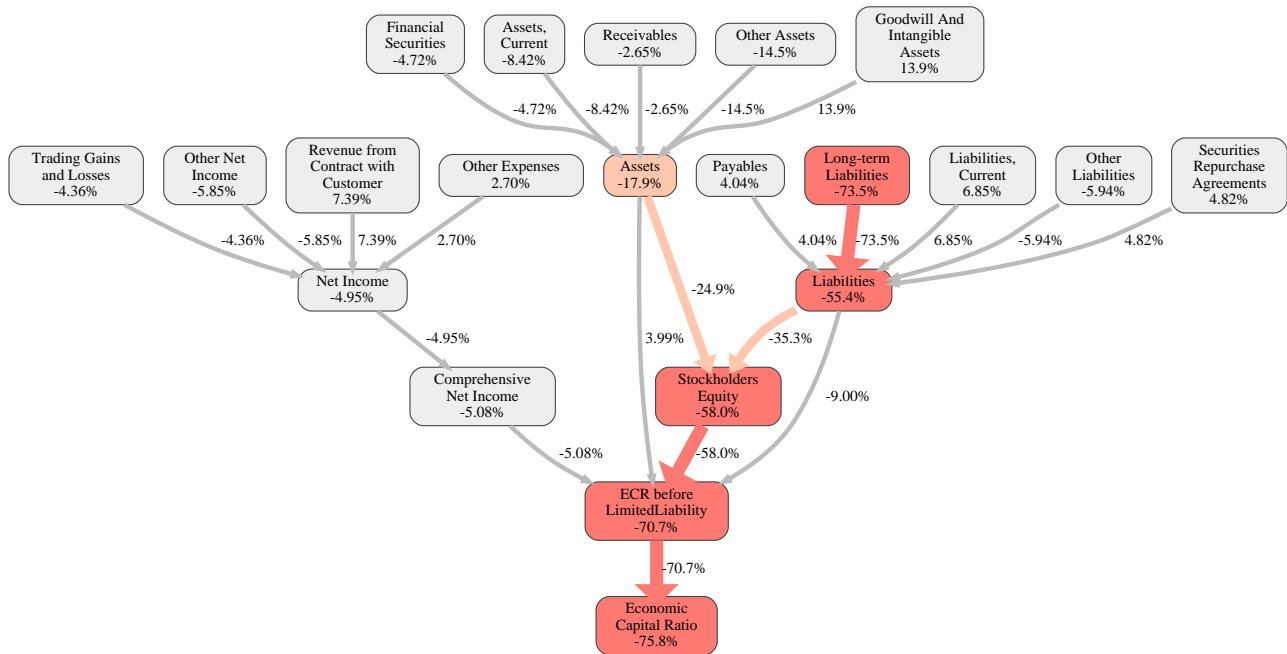

The greatest strength of Blackrock Finance Inc compared to the market average is the variable Goodwill And Intangible Assets, increasing the Economic Capital Ratio by 14% points. The greatest weakness of Blackrock Finance Inc is the variable Long-term Liabilities, reducing the Economic Capital Ratio by 73% points.

The company's Economic Capital Ratio, given in the ranking table, is 76%, being 76% points below the market average of 151%.
