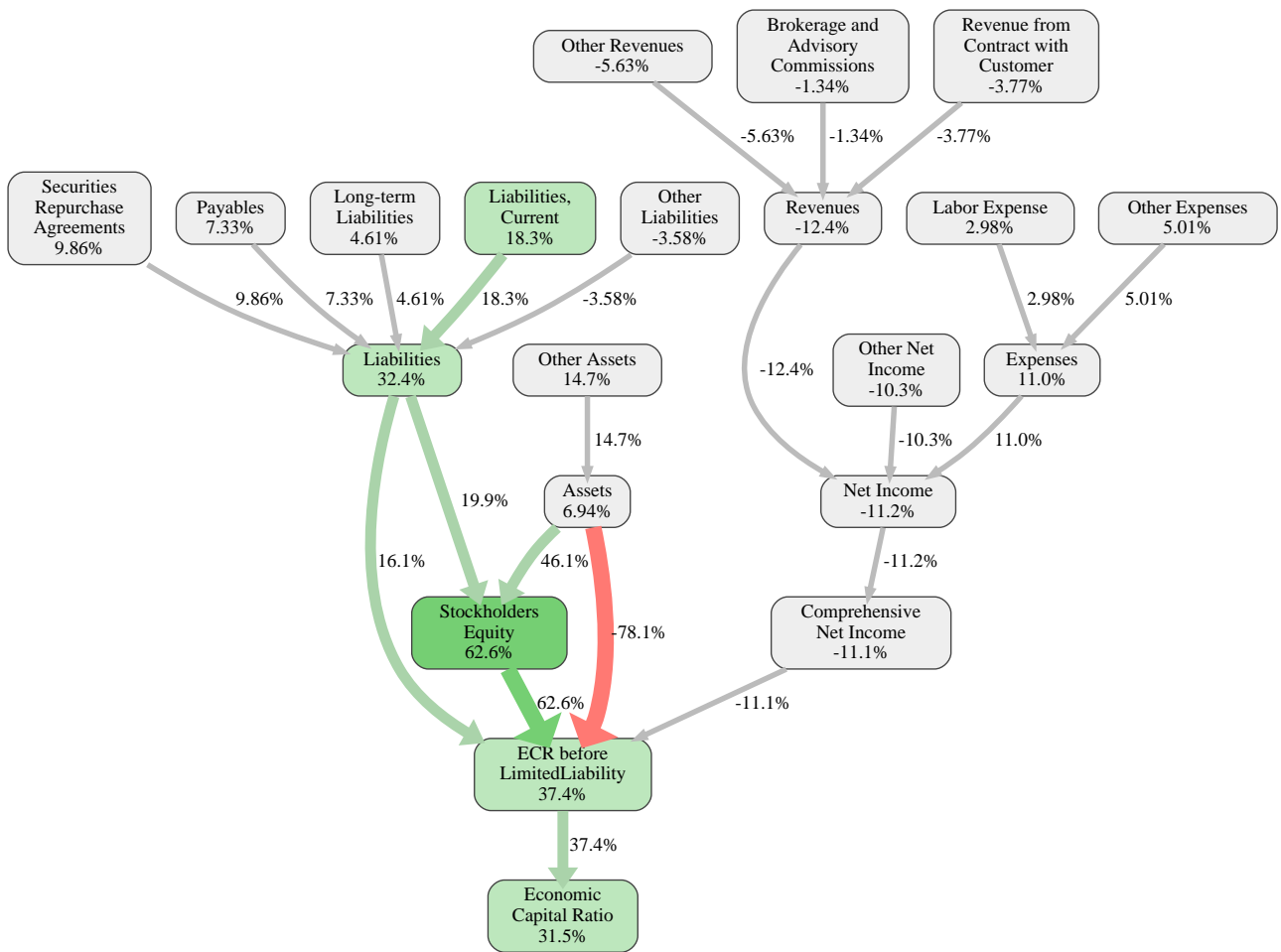

Proshares Trust II Rank 19 of 43

The relative strengths and weaknesses of Proshares Trust II are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Proshares Trust II compared to the market average is the variable Stockholders Equity, increasing the Economic Capital Ratio by 63% points. The greatest weakness of Proshares Trust II is the variable Revenues, reducing the Economic Capital Ratio by 12% points.

The company's Economic Capital Ratio, given in the ranking table, is 173%, being 32% points above the market average of 141%.
