The greatest strength of Huaizhong Health Group Inc compared to the market average is the variable Liabilities, increasing the Economic Capital Ratio by 420% points. The greatest weakness of Huaizhong Health Group Inc is the variable Other Expenses, reducing the Economic Capital Ratio by 200% points.

The company's Economic Capital Ratio, given in the ranking table, is 658%, being 283% points above the market average of 375%.
