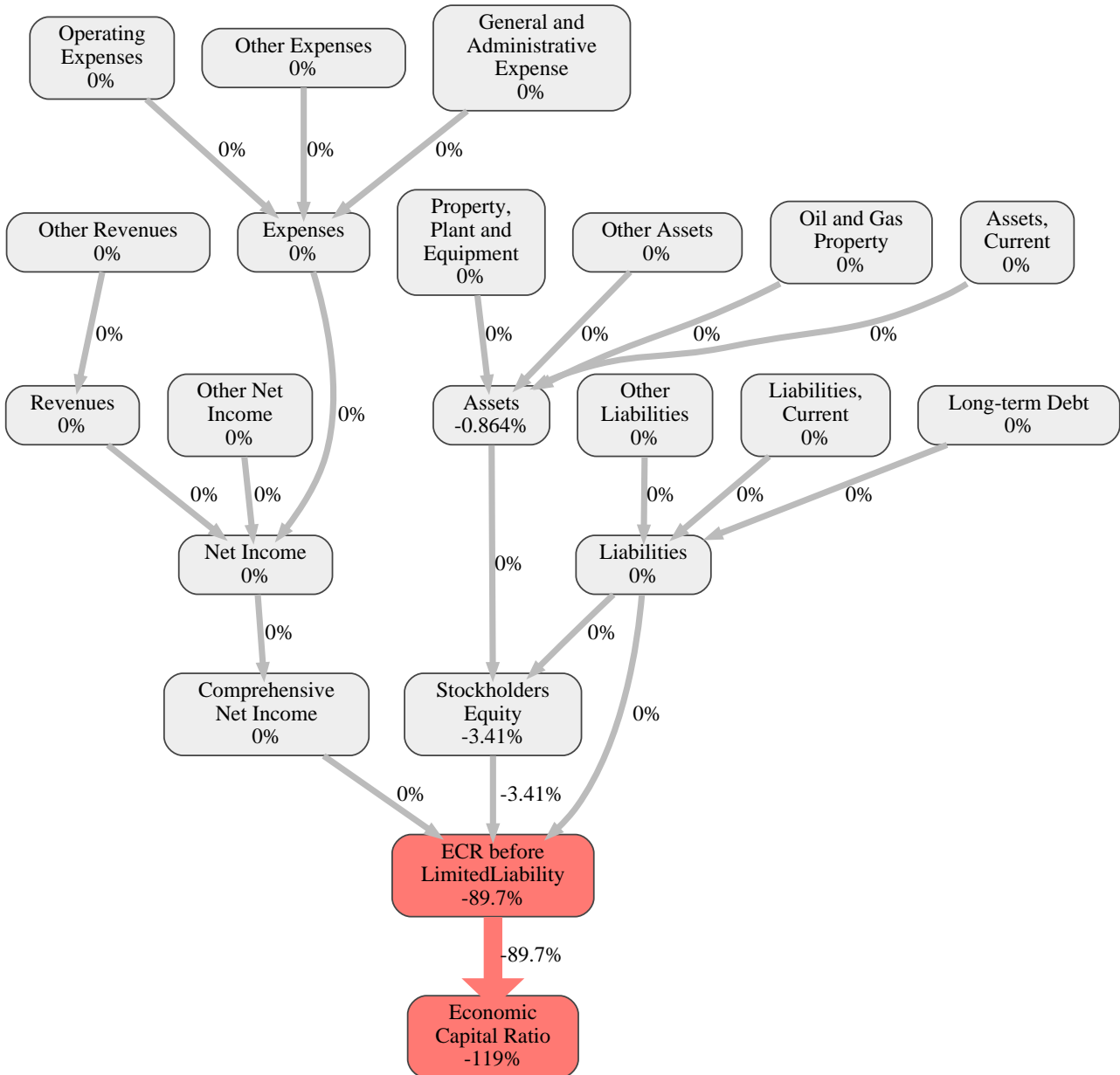

The greatest strength of Gulfslope Energy INC compared to the market average is the variable Liabilities, Current, increasing the Economic Capital Ratio by 0.000000000000000000000000000030% points. The greatest weakness of Gulfslope Energy INC is the variable Stockholders Equity, reducing the Economic Capital Ratio by 3.4% points.

The company's Economic Capital Ratio, given in the ranking table, is 0%, being 119% points below the market average of 119%.
