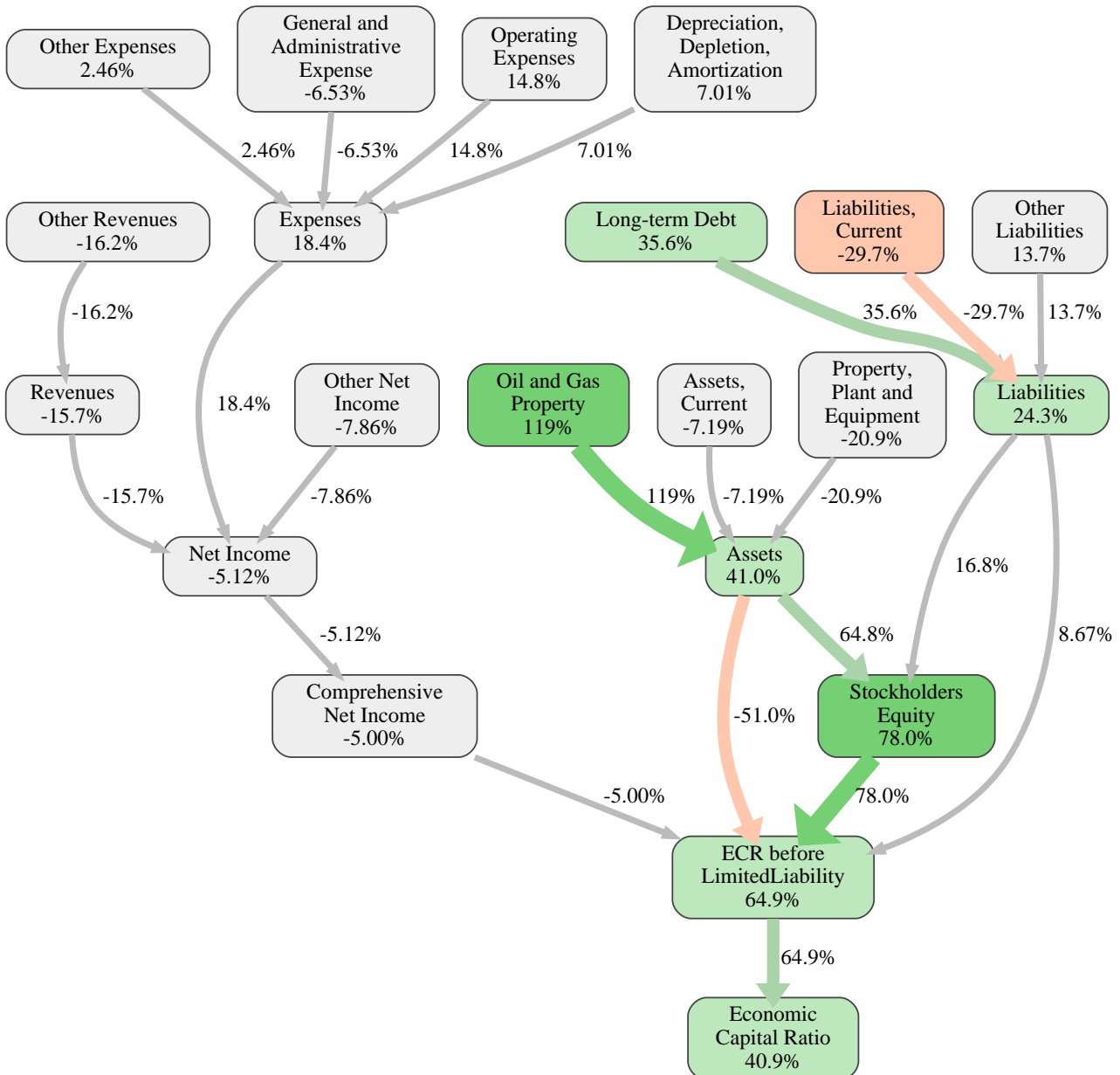

The relative strengths and weaknesses of Texas South Energy Inc are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Texas South Energy Inc compared to the market average is the variable Oil and Gas Property, increasing the Economic Capital Ratio by 119% points. The greatest weakness of Texas South Energy Inc is the variable Liabilities, Current, reducing the Economic Capital Ratio by 30% points.

The company's Economic Capital Ratio, given in the ranking table, is 139%, being 41% points above the market average of 98%.
