The greatest strength of Sustainable Projects Group Inc compared to the market average is the variable Other Assets, increasing the Economic Capital Ratio by 76% points. The greatest weakness of Sustainable Projects Group Inc is the variable Operating Expenses, reducing the Economic Capital Ratio by 123% points.

The company's Economic Capital Ratio, given in the ranking table, is 76%, being 32% points below the market average of 107%.
