

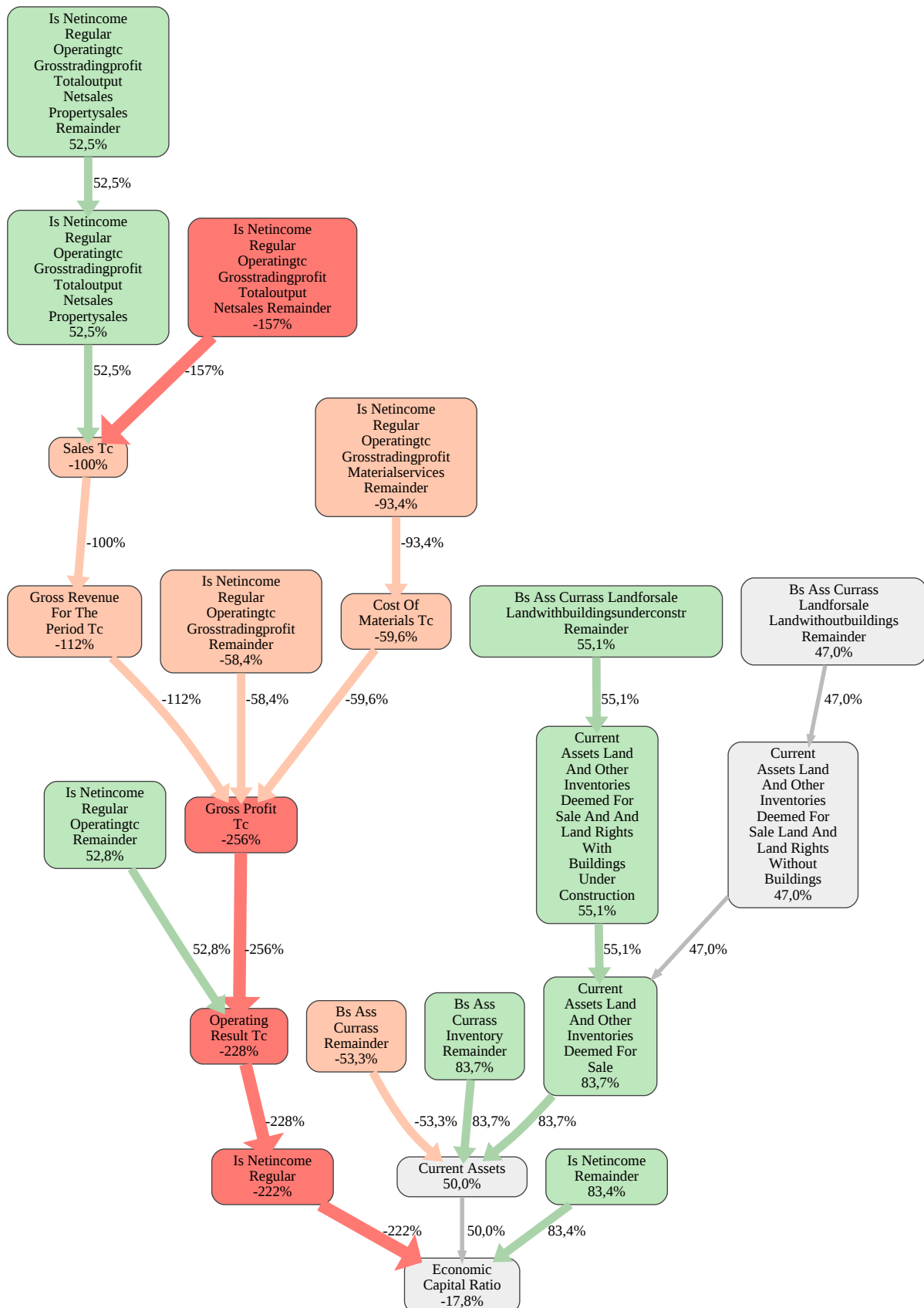

The relative strengths and weaknesses of Stuckert Wohnbau Aktiengesellschaft are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Stuckert Wohnbau Aktiengesellschaft compared to the market average is the variable Current Assets Land And Other Inventories Deemed For Sale, increasing the Economic Capital Ratio by 84% points. The greatest weakness of Stuckert Wohnbau Aktiengesellschaft is the variable Gross Profit Tc, reducing the Economic Capital Ratio by 256% points.

The company's Economic Capital Ratio, given in the ranking table, is 84%, being 18% points below the market average of 102%.
