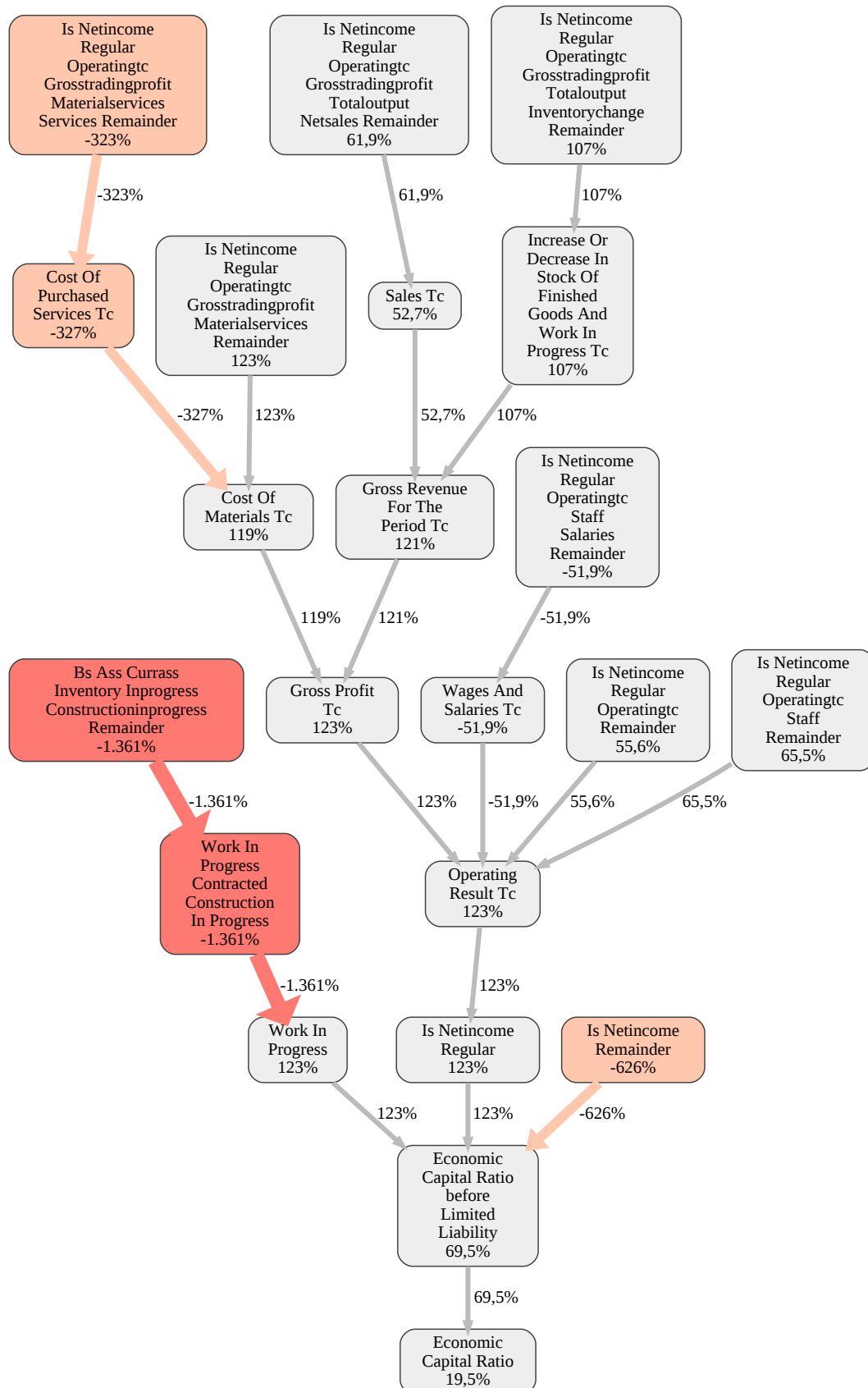

The greatest strength of Otto Wulff Bauunternehmung GmbH compared to the market average is the variable Work In Progress, increasing the Economic Capital Ratio by 123% points. The greatest weakness of Otto Wulff Bauunternehmung GmbH is the variable Bs Ass Currass Inventory Inprogress Constructioninprogress Remainder, reducing the Economic Capital Ratio by 1.361% points.

The company's Economic Capital Ratio, given in the ranking table, is 123%, being 20% points above the market average of 103%.
