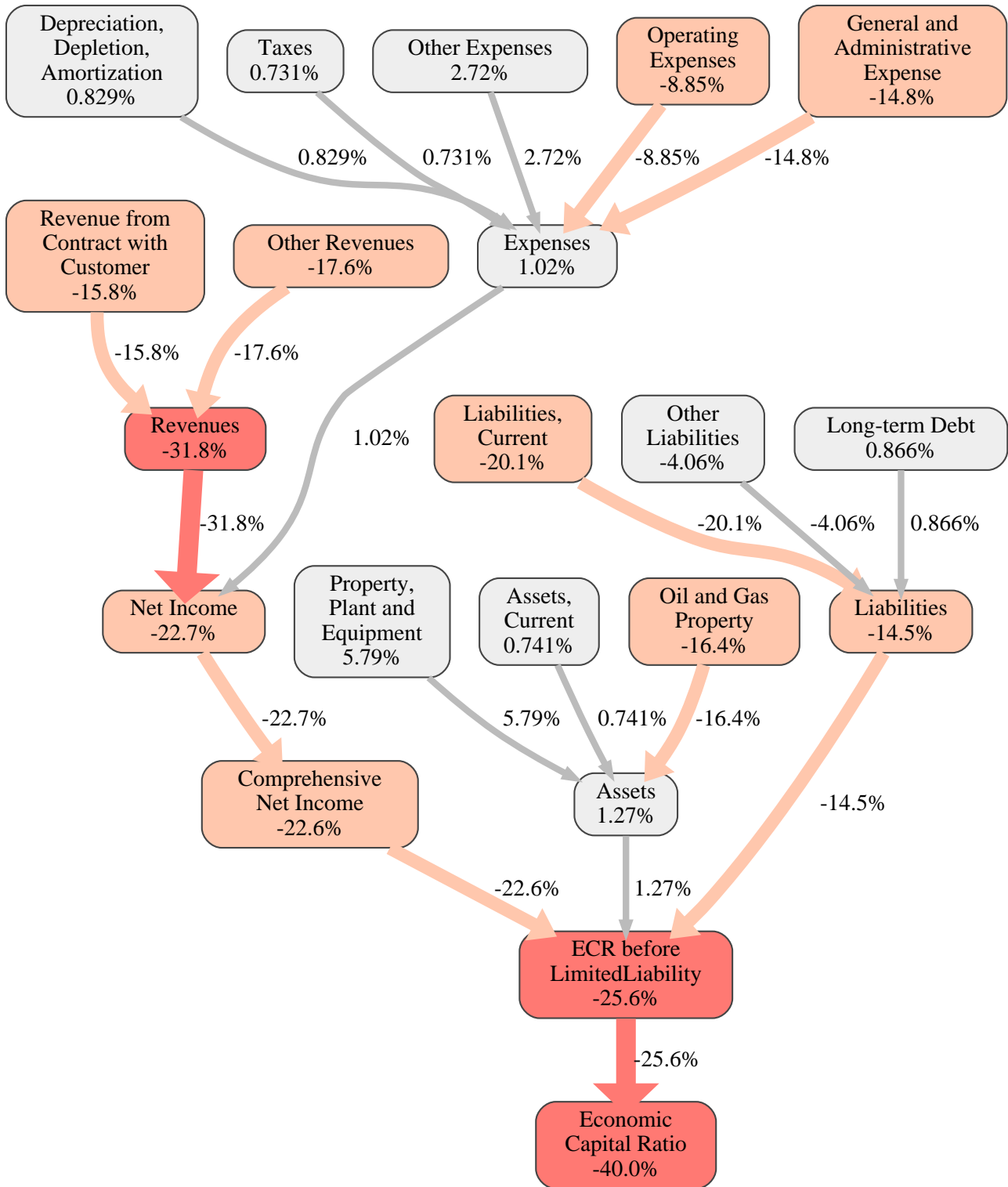

The relative strengths and weaknesses of Texas South Energy Inc are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Texas South Energy Inc compared to the market average is the variable Property, Plant and Equipment, increasing the Economic Capital Ratio by 5.8% points. The greatest weakness of Texas South Energy Inc is the variable Revenues, reducing the Economic Capital Ratio by 32% points.

The company's Economic Capital Ratio, given in the ranking table, is 55%, being 40% points below the market average of 95%.
