

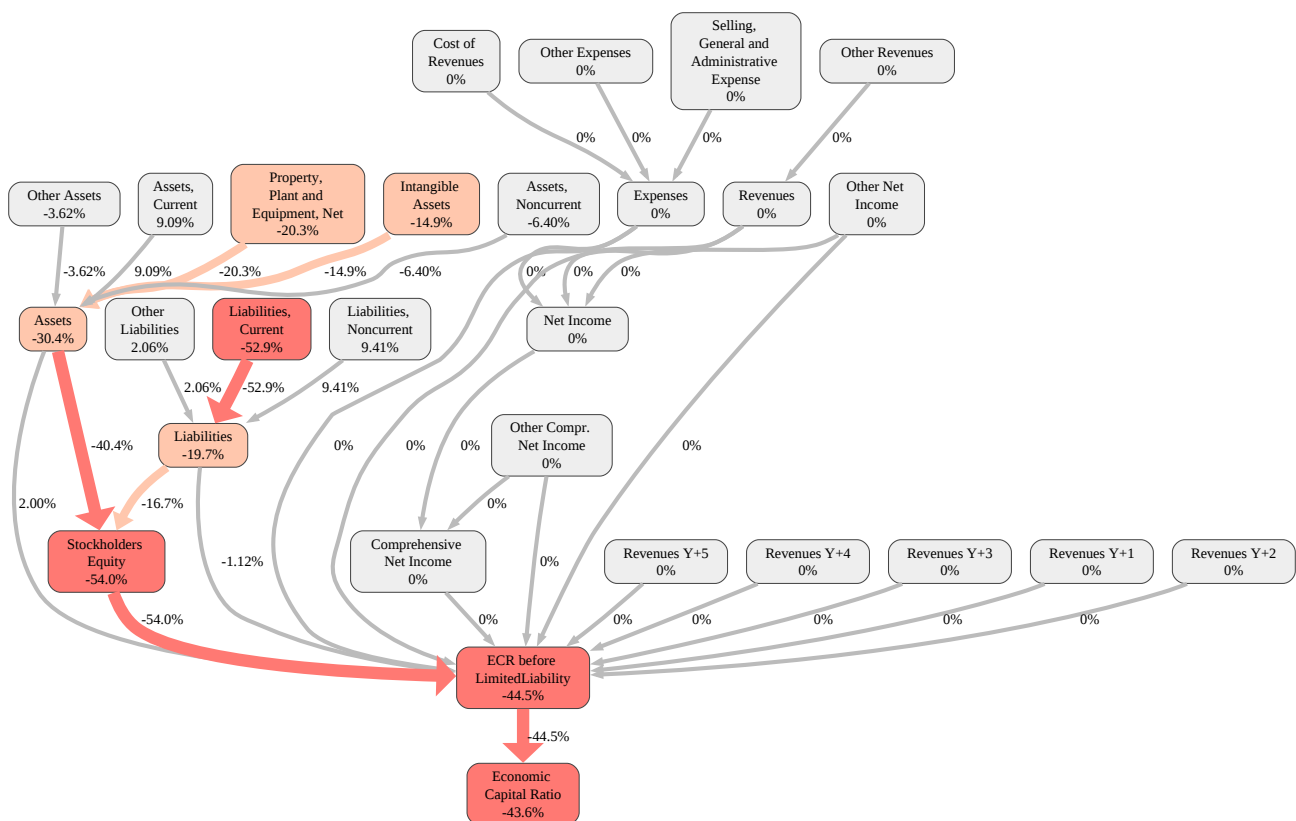

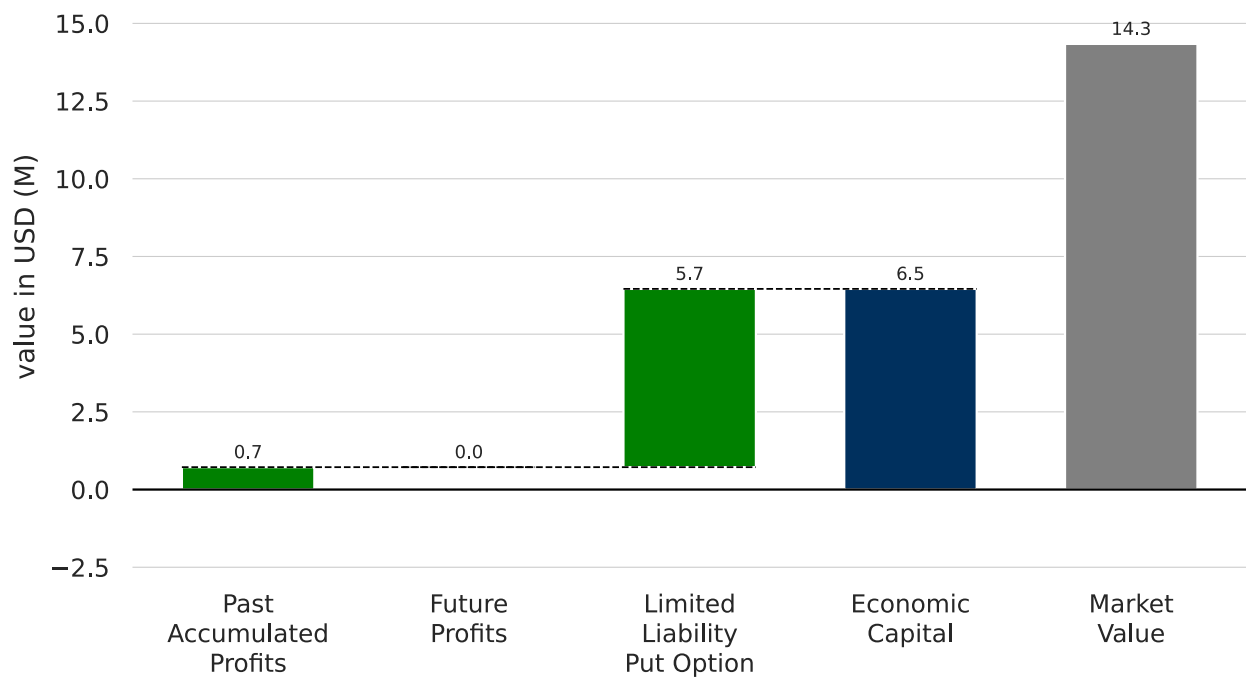
The greatest strength of TOMI Environmental Solutions Inc compared to the market average is the variable Liabilities, Noncurrent, increasing the Economic Capital Ratio by 9.4% points. The greatest weakness of TOMI Environmental Solutions Inc is the variable Stockholders Equity, reducing the Economic Capital Ratio by 54% points.

The company's Economic Capital Ratio, given in the ranking table, is 83%, being 44% points below the market average of 127%.

### Company Valuation: TOMI Environmental Solutions Inc



The RealRate Economic Capital of a company is its Past Accumulated Profits plus its Future Profits plus its Valuation Correction plus its Limited Liability Put Option. Past Accumulated Profits and Future Profits can be negative. The Limited Liability Put Option accounts for the limited liability of the shareholders, so the Economic Capital never falls below zero. Where the company is listed, its market value is shown next to it.
