

The greatest strength of Xaver Lutzenberger GmbH Co KG Bauunternehmung compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Totaloutput Netsales Rem, increasing the Economic Capital Ratio by 116% points. The greatest weakness of Xaver Lutzenberger GmbH Co KG Bauunternehmung is the variable Is Netincome Regular Rem, reducing the Economic Capital Ratio by 1.171% points.

The company's Economic Capital Ratio, given in the ranking table, is 116%, being 14% points above the market average of 101%.
