

The greatest strength of W Markgraf GmbH Co KG Bauunternehmung compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Rem, increasing the Economic Capital Ratio by 111% points. The greatest weakness of W Markgraf GmbH Co KG Bauunternehmung is the variable Is Netincome Rem, reducing the Economic Capital Ratio by 480% points.

The company's Economic Capital Ratio, given in the ranking table, is 111%, being 4,0% points above the market average of 107%.
