

The relative strengths and weaknesses of Bauunternehmung Albert Weil Aktiengesellschaft Konzern are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Bauunternehmung Albert Weil Aktiengesellschaft Konzern compared to the market average is the variable Is Netincome Regular, increasing the Economic Capital Ratio by 59% points. The greatest weakness of Bauunternehmung Albert Weil Aktiengesellschaft Konzern is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Rem, reducing the Economic Capital Ratio by 155% points.

The company's Economic Capital Ratio, given in the ranking table, is 68%, being 39% points below the market average of 107%.
