



The relative strengths and weaknesses of Agri Fintech Holdings INC are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Agri Fintech Holdings INC compared to the market average is the variable Assets, Current, increasing the Economic Capital Ratio by 348% points. The greatest weakness of Agri Fintech Holdings INC is the variable Other Expenses, reducing the Economic Capital Ratio by 123% points.

The company's Economic Capital Ratio, given in the ranking table, is -262%, being 204% points above the market average of -467%.
