The relative strengths and weaknesses of Lendway INC are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Lendway INC compared to the market average is the variable Other Expenses, increasing the Economic Capital Ratio by 295% points. The greatest weakness of Lendway INC is the variable Cost of Goods and Services Sold, reducing the Economic Capital Ratio by 491% points.

The company's Economic Capital Ratio, given in the ranking table, is -75%, being 41% points above the market average of -116%.
