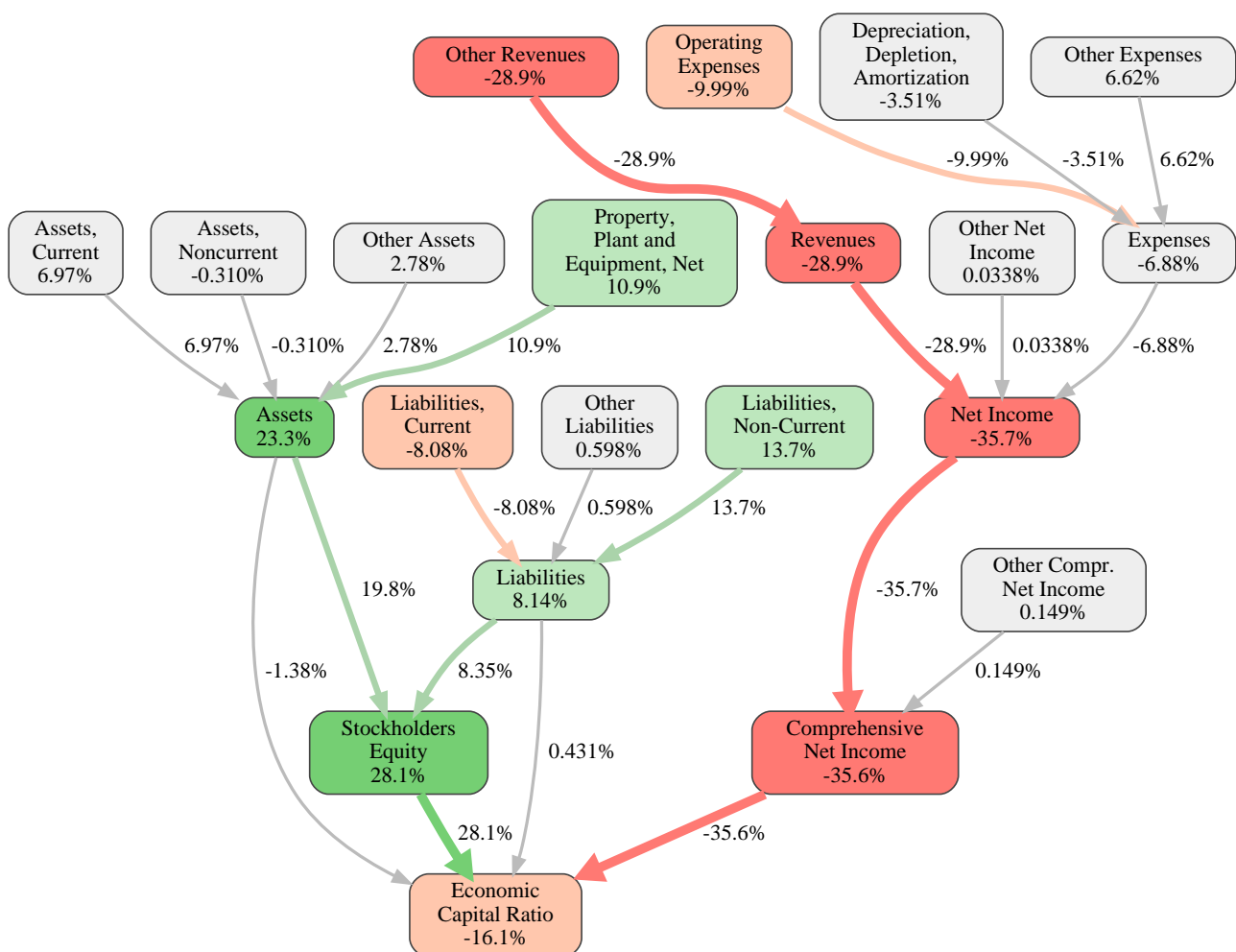

The relative strengths and weaknesses of Hawaiian Holdings INC are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Hawaiian Holdings INC compared to the market average is the variable Liabilities, Non-Current, increasing the Economic Capital Ratio by 14% points. The greatest weakness of Hawaiian Holdings INC is the variable Net Income, reducing the Economic Capital Ratio by 36% points.

The company's Economic Capital Ratio, given in the ranking table, is 5.6%, being 16% points below the market average of 22%.
