The relative strengths and weaknesses of Nyse Euronext are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Nyse Euronext compared to the market average is the variable Goodwill And Intangible Assets, increasing the Economic Capital Ratio by 88% points. The greatest weakness of Nyse Euronext is the variable Other Assets, reducing the Economic Capital Ratio by 33% points.

The company's Economic Capital Ratio, given in the ranking table, is 83%, being 17% points below the market average of 100%.
