

The relative strengths and weaknesses of Abrdn Palladium ETF Trust are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Abrdn Palladium ETF Trust compared to the market average is the variable Expenses, increasing the Economic Capital Ratio by 19% points. The greatest weakness of Abrdn Palladium ETF Trust is the variable Revenues, reducing the Economic Capital Ratio by 14% points.

The company's Economic Capital Ratio, given in the ranking table, is 223%, being 82% points above the market average of 140%.
