

### MLM Index Fund Rank 28 of 100

The relative strengths and weaknesses of MLM Index Fund are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of MLM Index Fund compared to the market average is the variable Expenses, increasing the Economic Capital Ratio by 16% points. The greatest weakness of MLM Index Fund is the variable Revenues, reducing the Economic Capital Ratio by 8.2% points.

The company's Economic Capital Ratio, given in the ranking table, is 225%, being 75% points above the market average of 150%.
