

The relative strengths and weaknesses of Wisdomtree Continuous Commodity Index Fund are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Wisdomtree Continuous Commodity Index Fund compared to the market average is the variable Expenses, increasing the Economic Capital Ratio by 20% points. The greatest weakness of Wisdomtree Continuous Commodity Index Fund is the variable Other Net Income, reducing the Economic Capital Ratio by 41% points.

The company's Economic Capital Ratio, given in the ranking table, is 177%, being 36% points above the market average of 142%.
