The greatest strength of United States Gasoline Fund Lp compared to the market average is the variable Other Liabilities, increasing the Economic Capital Ratio by 16% points. The greatest weakness of United States Gasoline Fund Lp is the variable Assets, Current, reducing the Economic Capital Ratio by 37% points.

The company's Economic Capital Ratio, given in the ranking table, is 237%, being 83% points above the market average of 154%.
