The greatest strength of United States Oil Fund Lp compared to the market average is the variable Net Income, increasing the Economic Capital Ratio by 66% points. The greatest weakness of United States Oil Fund Lp is the variable Assets, Current, reducing the Economic Capital Ratio by 124% points.

The company's Economic Capital Ratio, given in the ranking table, is 284%, being 131% points above the market average of 153%.
