The relative strengths and weaknesses of MAN AHL Diversified I Lp are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of MAN AHL Diversified I Lp compared to the market average is the variable Other Assets, increasing the Economic Capital Ratio by 16% points. The greatest weakness of MAN AHL Diversified I Lp is the variable Revenues, reducing the Economic Capital Ratio by 13% points.

The company's Economic Capital Ratio, given in the ranking table, is 205%, being 55% points above the market average of 151%.
