The greatest strength of Invesco Currencyshares Australian Dollar Trust compared to the market average is the variable Other Assets, increasing the Economic Capital Ratio by 21% points. The greatest weakness of Invesco Currencyshares Australian Dollar Trust is the variable Other Liabilities, reducing the Economic Capital Ratio by 19% points.

The company's Economic Capital Ratio, given in the ranking table, is 192%, being 45% points above the market average of 146%.
