The relative strengths and weaknesses of LUXFER HOLDINGS PLC are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of LUXFER HOLDINGS PLC compared to the market average is the variable Other Revenues, increasing the Economic Capital Ratio by 182% points. The greatest weakness of LUXFER HOLDINGS PLC is the variable Cost of Revenues, reducing the Economic Capital Ratio by 128% points.

The company's Economic Capital Ratio, given in the ranking table, is 85%, being 48% points above the market average of 38%.
