



The relative strengths and weaknesses of Elite Health Systems Inc are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Elite Health Systems Inc compared to the market average is the variable Long Term Liabilities, increasing the Economic Capital Ratio by 130% points. The greatest weakness of Elite Health Systems Inc is the variable Other Net Income, reducing the Economic Capital Ratio by 30% points.

The company's Economic Capital Ratio, given in the ranking table, is 463%, being 333% points above the market average of 130%.
