



The relative strengths and weaknesses of Elite Health Systems Inc are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Elite Health Systems Inc compared to the market average is the variable Long Term Liabilities, increasing the Economic Capital Ratio by 97% points. The greatest weakness of Elite Health Systems Inc is the variable General and Administrative Expense, reducing the Economic Capital Ratio by 28% points.

The company's Economic Capital Ratio, given in the ranking table, is 424%, being 238% points above the market average of 186%.
