The greatest strength of LHC Group Inc compared to the market average is the variable Intangible Assets, increasing the Economic Capital Ratio by 154% points. The greatest weakness of LHC Group Inc is the variable Assets, Current, reducing the Economic Capital Ratio by 69% points.

The company's Economic Capital Ratio, given in the ranking table, is 232%, being 46% points above the market average of 186%.
