The relative strengths and weaknesses of Sunlink Health Systems INC are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Sunlink Health Systems INC compared to the market average is the variable Net Income, increasing the Economic Capital Ratio by 175% points. The greatest weakness of Sunlink Health Systems INC is the variable Labor Expense, reducing the Economic Capital Ratio by 93% points.

The company's Economic Capital Ratio, given in the ranking table, is 388%, being 300% points above the market average of 89%.
