




## Elite Health Systems Inc Rank 30 of 97

The relative strengths and weaknesses of Elite Health Systems Inc are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Elite Health Systems Inc compared to the market average is the variable Assets, Current, increasing the Economic Capital Ratio by 328% points. The greatest weakness of Elite Health Systems Inc is the variable Net Income, reducing the Economic Capital Ratio by 108% points.

The company's Economic Capital Ratio, given in the ranking table, is 243%, being 154% points above the market average of 89%.
