

## National Security Group INC Rank 2 of 27

The relative strengths and weaknesses of National Security Group INC are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of National Security Group INC compared to the market average is the variable Revenues, increasing the Economic Capital Ratio by 39% points. The greatest weakness of National Security Group INC is the variable Expenses, reducing the Economic Capital Ratio by 35% points.

The company's Economic Capital Ratio, given in the ranking table, is 17%, being 12% points above the market average of 4.9%.
