

# Reinsurance Group Of America INC Rank 11 of 23



The relative strengths and weaknesses of Reinsurance Group Of America INC are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Reinsurance Group Of America INC compared to the market average is the variable Debt Securities, Available-for-sale, increasing the Economic Capital Ratio by 17% points. The greatest weakness of Reinsurance Group Of America INC is the variable Other Assets, reducing the Economic Capital Ratio by 9.4% points.

The company's Economic Capital Ratio, given in the ranking table, is 6.3%, being 1.4% points below the market average of 7.7%.
