The relative strengths and weaknesses of Vericity Inc are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Vericity Inc compared to the market average is the variable Revenues, increasing the Economic Capital Ratio by 12% points. The greatest weakness of Vericity Inc is the variable Liability for Future Policy Benefit, reducing the Economic Capital Ratio by 17% points.

The company's Economic Capital Ratio, given in the ranking table, is -0.82%, being 13% points above the market average of -14%.
