



The relative strengths and weaknesses of HECLA MINING CO DE are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of HECLA MINING CO DE compared to the market average is the variable Property, Plant and Equipment, increasing the Economic Capital Ratio by 110% points. The greatest weakness of HECLA MINING CO DE is the variable Liabilities, Non-Current, reducing the Economic Capital Ratio by 31% points.

The company's Economic Capital Ratio, given in the ranking table, is 115%, being 161% points above the market average of -47%.
