The relative strengths and weaknesses of NACCO INDUSTRIES INC are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of NACCO INDUSTRIES INC compared to the market average is the variable Liabilities, Current, increasing the Economic Capital Ratio by 68% points. The greatest weakness of NACCO INDUSTRIES INC is the variable Cost of Revenue, reducing the Economic Capital Ratio by 24% points.

The company's Economic Capital Ratio, given in the ranking table, is 151%, being 187% points above the market average of -36%.
